Volunteers, through the Department of Veterans Affairs Voluntary Service (VAVS) Program, balance the needs of the hospitalized patients by providing that extra encouragement, love, and spirit that cannot be administered by medical staff. A volunteer is often the patient's only contact with the world beyond the walls of the facility, and his or her presence can mean the difference between a patient will to respond to treatment or to sink into despair. The Ladies Auxiliary V.F.W. volunteers supplement the services provided by staff professionals and perform many duties, which contribute substantially to the welfare of the patients. Through our Hospital Program volunteers serve in VA, military, community, children's hospitals, nursing and convalescent homes, therapy centers, outpatient clinics, and satellite facilities where veterans and/or their dependents are patients or residents. In this age of budget constraints and considering the aging of the veteran population, the need for volunteers has accelerated. Because auxiliary volunteers are also aging, recruiting becomes an increasingly vital part of the VAVS / Hospital Program. #### Reserve and National Guard benefits

The Department of Veterans Affairs had a negative view of Reserve and National Guard service for decades. These days, most reserve and National Guard members have been mobilized to federal active duty at least once, and many several times. Mobilization is bona fide active duty, and the "de-mobed" Reservist or National Guard service member can waive a DD Form 214 under the VA's nose to prove it.

Let's look at: 1) "ADT confusion", and 2) a summary of Reserve/National Guard VA benefits.

1) I first drafted these words in 2006 in a motel lobby in Alexandria, Virginia, having been called to active duty to help stand up the Defense Joint Intelligence Operations Center in Washington, D.C. That duty was NOT training. However, my Army Reserve orders read "active duty for training" (ADT). My 2½ years of earlier mobilizations were also paid via ADT orders. The Army Reserve pay system did not reflect reality. Now, nine years plus after 9/11, the Reserve and National Guard system for ordering soldiers, airmen, and Marines to active duty STILL is an artifact left over from the Cold War – a time of generating ["cutting"] orders for basic training, specialty schools, two weeks of annual training each year, and that's about it.

I know a widow of a reservist killed while mobilized. She was initially denied his federal grave marker by the Department of Veterans Affairs because he had been, in the eyes of the VA, on "active duty for training" and not real active duty. She later provided his DD Form 214 and was granted the marker. (The separation date from active duty on his DD-214 was the day he was killed, in case you were wondering how that works.) She should not have had to suffer that indignity and hassle because of the Department of Defense and Department of Veterans Affairs inability to understand each other – a problem exacerbated by the archaic Reserve and National Guard active duty orders system.

In the pre-9/11 era, an "ADT" designator on orders was a tip-off to the VA that the period of military service was purely for Reserve or National Guard basic or skills training. These students could not be assigned without warning – as could their full-time active duty counterparts – to jump into combat, fight grass fires in California, or to any other nontraining duty. They did not fully belong to the active duty chain of command. Accordingly, the VA did not consider ADT service, however long, as qualifying for the majority of benefit programs. A nine-month ADT school tour did not qualify a Reservist for a VA home loan in the 1970s for example. The home loan qualification requirement at that time was a minimum of 180 days of active duty: that's AD and not ADT.

2) Reservists and National Guard members who were NEVER mobilized ARE eligible for the following benefits:

Home loans if served at least six years (less, if separated due to a service connected disability); Montgomery G.I. Bill educational benefits under section 1606; and military funeral honors and memorial flag if died before end of obligated service or if completed at least one term of service. The never-mobed Reservist would also be eligible for burial in a national cemetery if eligible for reserve retirement at age 60, died while on duty, or died as a result of a service connected disability.

The never-mobed Reservist would be eligible for service connected disability compensation, medical care, possibly vocational rehabilitation, Indiana property tax deduction, and children's tuition and fees remission at state supported schools if disabled while on reserve duty or in transit to or from reserve duty. He or she could also get CHAMPVA health care and Chapter 35 educational payments for spouse and dependent children if 100% service connected disabled - and dependency and indemnity compensation if he or she died a service connected death.

There have been several serious proposals over the years to streamline and deconflict the administrative system used to generate orders for Reservists and National Guard members. Somehow, there are always "more important" things for the DoD and VA to worry about and this continuing problem, that hurts their most important resource – people – always gets put on the back burner. Don't hold your breath.



#### Why a House Committee?

Below is an excerpt from the VFW Indiana Department rules and regulations:

- 11. A House Committee shall be elected by the Post membership to act as a board of management for the business affairs of the Club. This House Committee shall consist of three (3) members, one of which shall be elected each year for a three (3) year period. No members of the House Committee shall succeed to membership on such committee automatically by virtue of election to any Post Office. Post Trustees shall not be elected to the House Committee. The House Committee shall elect a Chairman yearly. All members of the House Committee shall be elected and not appointed. A House Committee member, who resigns or is removed from office, will be replaced by the election of a new member to fill the vacant position. The other two (2) members will remain in their present year of offices.
- 12. The House Committee may suspend Club privileges of any Post member, Ladies Aux., Men's Aux., or guest who is guilty of any misconduct on the Club premises, for whatever period of time they shall determine proper, by presenting him/her with written notice. Final decision shall be made by a majority vote of the members present at the next regular or special meeting, after suspended member has received such notice.
- 13. The Post membership may overrule or abrogate any action of the House Committee by a majority vote at regular or duly called special meeting. Any House Committee member may be removed from office in the event he/she has committed an offense specified in Article IX, Section 902 procedural guide for disciplinary action of the National Constitution and By-Laws. Determination that the House Committee member has committed such offense, in Article IX Section 902, shall be by a majority vote of membership present at a regular or duly called meeting to remove a House Committee Member. This action may only be taken after the accused has been given seven (7) days written notice.
- 17. ... members of the House Committee shall be held responsible by the Post Commander and the Post Floor to know and strictly enforce at all times the By-Laws of the Club, Indiana Department rules and regulations, the Indiana Alcoholic Beverage Act and Amendments thereto, and the Indiana Charitable Gaming Commission regulations.
