Board of Veterans Appeals hearing in Washington, DC

Late last year I was completing a VA Form 9, the formal Department of Veterans Affairs appeal form. I checked the block indicating I wanted a personal hearing. Then I stopped and thought about the choices of hearing location and organizational level - in St. Louis, MO before a regional office hearing officer (The appeal pertained to educational benefits processed in the St. Louis regional office. The Indy regional office no longer does educational benefits other than vocational rehabilitation.), in Indianapolis before a Board of Veterans Appeals (BVA) traveling Veterans Law Judge, or in Washington, DC before a BVA Veterans Law Judge. I had already represented veterans during regional office appeal hearings and during hearings with traveling members of the BVA in Indy, but I had never even spoken to any veteran appellant who had a personal hearing before the BVA in Washington, DC. Soes Ah dun checked the BVA in Washington, DC block. Heck, I wanted to see DC again anyway. A few months later I got the appointment

Did you ever read Dave Barry's description of his colonoscopy? Pretty funny. Well, having a personal Board of Veterans Appeals hearing before a Veterans Law Judge wasn't exactly the same. As a matter of fact, it was not only painless, it was not bad at all. It turns out the Washington, DC BVA appointments are "blocked" for morning or afternoon. Mine was nominally at 1300 (That's one o'clock in the afternoon for you Air Force vets.) same as all the other afternoon hearings. The appointment

letter said that the order for conducting the hearings was the order in which the appellants signed in at the BVA building. (The BVA is proud that they are NOT collocated with the Department of Veterans Affairs Central Office.) I had flown a discounted US Air flight directly from Indy into Reagan National Airport which has its own METRO stop. The letter told me that the Judiciary Square METRO stop was the closest to the BVA building. Even though it was just a little after 0900, I decided to go ahead and sign in at the BVA. I followed the "if traveling by METRO" directions provided with the appointment letter – right up until the directions said to exit the underground METRO stop at the north end. I could not tell which way was north while underground, exited at the wrong end, and therefore did not see the free BVA - METRO shuttle van. I asked directions and walked about five blocks to the BVA.

Two security guards asked who I was and checked my ID. They X-rayed my luggage (Remember, I had gone directly to the BVA.) and I walked through a magnetic metal detector, just like at an airport. The BVA receptionist introduced herself and asked if I wanted a representative? (I said no, which is stupid, but I already knew the issues and the evidence.) She then surprised me by saying that the judge on duty for hearings might see me that morning! The receptionist then showed me to one of two "prep" rooms, normally used for the appellants and representatives to go over the veteran's claims folder, discuss the case, plan their testimony, and if the need occurs – visit the restroom located between the two prep rooms. She asked if I wanted to review my own claim folder? I said yes, and she went to get it. I went to the rest and recuperation room to change out of a sweaty shirt and into a clean one, tie, and jacket. The receptionist returned with my folder shortly before the judge said he was ready if I was. He and I shook hands and we went into the hearing room. Unlike regional office hearing rooms which are usually small, one table with three or four chairs, and with simple voice recording equipment, the Washington, DC Board of Veterans Appeals hearing room was LARGE, obviously designed for the purpose, the judge sat behind a big and slightly elevated judicial-style bench, and there was a simple table in front of his bench with microphones and chairs for the appellant and a representative. All the furniture was dark. All the lighting was modern. There were offwhite curtains on the wall behind the bench. The other three walls were plain grey. The judge and I talked weather and travel and Indiana for a few minutes, then he briefed me on how the hearing would be conducted (exactly the same as any other VA hearing), I was sworn, made my opening statement, we did the question and answer routine, I closed, he thanked me for my service, we shook hands, and I left. I took the free shuttle this time.

Commander's Weekly Drawing

<u>It's Back</u> by popular demand, however due to changes in gaming regulations, it is not the same game you remember. We think it is better and that you will agree. Here's how the game shall be played:

- 1. All VFW, Ladies Auxiliary, and Men's Auxiliary members in good standing are eligible to play.
- 2. Each member shall be assigned a random number ranging from 0001 up to the total number of members eligible that week and shall be recorded on Club Roster. The Roster shall be clearly marked with the period for which the roster shall be used and be posted in the Canteen.
- 3. New members are eligible the week following acceptance into the club.
- 4. The eligible player must sign up before that week's drawing to be held Friday evening at 7:00, by paying their \$1.00 and signing that weeks Club Roster located in the Canteen.
- 5. A patron shall witness the random computer generated number drawing as an impartial observer and shall sign as a witness to the drawing.

Payout:

- 1. The Commander must distribute all monies received from members, and the club shall not deduct any fees from the monies collected.
- 2. Commanders Weekly Drawing monies collected prior to 2009, that were not distributed prior to the old posts closure, shall be the start-up funds for the Commander's Weekly Drawing.
- 3. The playing member, who pays \$1.00 and has signed that weeks Club Roster located in the Canteen, will be declared the winner if the random number drawn is equal to the number displayed on that weeks Club Roster for that member. The winner's identity will be posted in the Canteen.
- 4. If the winner is present at the time of the drawing, the winner shall collect ALL monies held by the Commander that were collected for the Commander's Weekly Drawing and were not previously distributed to winners.
- 5. If the winner is not present, the winner shall collect one half of ALL monies held by the Commander that were collected for the Commander's Weekly Drawing and were not previously distributed to winners.
- All monies collected not won based on these rules shall be advanced into the next week's Commander's Weekly Drawing.
- 7. The Commander shall pay the winner at the time of the drawing if present, otherwise the Commander shall make every attempt to contact the winner to arrange distribution of the winnings, or the Commander shall mail a Post check to the winner prior to the next drawing of the Commanders Weekly Drawing. ❖


