## Post 604 Champions "Space A" Benefit

A few weeks ago Polly and I took a "Space A" [space available] contract flight from Baltimore, MD to Ramstein AFB, Germany. Cost: \$32.20. A week later we returned from Ramstein AFB to McGuire AFB, NJ aboard a C-17 for \$0.00 [free]. We were eligible for this Air Mobility Command (AMC) version of commercial "stand-by" travel because I'm retired military and Polly is my dependent spouse. Retired military are "Category VI" [the sixth, and lowest, priority level]. We showed our military identification cards and passports at the AMC desk when registering for the flights. We probably never would have been able to afford the price of equivalent commercial flights and never would have seen Point du Hoc. Pegasus Bridge, Sainte-Mère-Église, Omaha Beach, or the American National Cemetery overlooking Omaha Beach. These sights were extremely meaningful for us as were the expressions of gratitude from the French people of Normandy.

What's wrong with this picture? After I sent out an email sharing some of the details of the trip, I received an interested response from Terri Languell. Most of you know Terri – who volunteers for nearly everything in Monroe County that has to do with helping veterans – but Terri is not retired from the military. She never had a chance to do so. An IED took care of that. Terri is rated 100% service connected disabled by the Department of Veterans Affairs. Under current regulations, Terri is not eligible for Space A travel.

As meaningful as the D-Day locations were to me, how much more meaningful would they be to a 100% service connected veteran? Bear in mind that many Department of Veteran Affairs 100% determinations are based on individual unemployability (IU) due to service connected disabilities. These IU disabled veterans are much less likely to ever have the financial resources to travel to the scenes of their sacrifice. The poignant irony is that many have the time to travel because of their inability to work.

While 100% disabled veterans can obtain a quasi-military ID card used for access to many other benefits, their spouses and other dependents are not eligible for registration in the Defense Enrollment Eligibility Reporting System (DEERS) and therefore cannot obtain a military dependent identification card. Space A regulations should be amended to include eligibility for one person to accompany each 100% service connected disabled veteran traveler. A by-name designation signed by the veteran should be sufficient. (I assume this person would normally be a spouse or friend, but in some cases the person might be a nurse or other caregiver.) The designated accompanying person, if any, would show current

government-issued identification bearing their photograph and/or passport during registration for a Space Available flight.

Objections that some 100% service connected disabled veterans are unsuited to travel are perhaps true, but not significantly more true for these veterans than for active duty or retired service members or dependents with disabilities, diagnosed and undiagnosed. No part of the current Space A regulations precludes travelers in any of the six categories from traveling due to artificial limbs or other impediments.

100% service connected veterans have commissary privileges, post/base exchange privileges, MWR privileges, and many other benefits they share with military retirees but not eligibility for Space Available flights. That's "What's wrong with this picture?"! There are empty seats every day on AMC military and Space A contract aircraft flights which could be put to good use for the benefit of those who gave so much, everything but their lives. All the Space A facilities, security measures, administrative staff, and procedures are already in place and operating. Extending this benefit to include 100% service connected veterans would cost virtually nothing.

Why not? Who deserves it more?

#### **HELP NEEDED**

Each month we are required to submit a Community Service Report to Headquarters. Your help is needed to insure Post 604 submits a complete report. The only way this can be accomplished accurately is for you, the member, to let us know of all community service projects you voluntarily participate in.

Below is a list of the categories of community service that are reportable:

- Community Involvement includes but not limited to - blood drives, CPR classes, recycling, highway cleanup, or other projects that benefit the community.
- 2. **Cooperation** with other organizations.
- 3. **Aid to others** examples are Food Bank, Nursing Home, Senior Citizen Centers, etc.
- 4. **School or Church Assistance** volunteer in School, Speaker of Program in School or Church or other assistance projects.
- Citizenship Education Flag presentation, Color/Honor Guard, Distributed Patriotic Literature, Conducted "Get Out To Vote", Conducted Patriotic Programs in Schools, Veterans day, Pearl Harbor, Memorial Day, Loyalty Day Programs or other Americanism Projects.
- 6. **Safety** Pedestrian safety, Drug Awareness, Recreational Safety, Highway Safety, Home/Fire Safety, Other Safety Projects and Public Recognition
- 7. **Youth Activities** Sports or Athletics, Boy or Girl Scouts, Other Youth Groups, Contests or Special Events, Education, Recognition to Youth Groups.

The above are just some examples of the types of community service projects that can be reported. If you are not sure if your project is reportable, please submit it anyway.

When submitting a report be sure to include Name, Money Spent (if any), Number of Hours (report any portion of an hour as a full hour and be sure to include the time you travel to and from your residence), Miles Involved, and a brief description of the project. If you have access to email you can send you report to me at Lanningbob@yahoo.com.

If you don't have email capabilities, you can complete a informal short written report and drop it off at the VFW post or bring to monthly meeting with you. Be sure to include the following information when submitting a written report or emailing.

## New Compensation Payments Begin

The VA began paying disability compensation to Vietnam veterans who qualify under the three new presumptive illnesses associated with Agent Orange exposure — B-cell (or hairy-cell) leukemia, Parkinson's disease and ischemic heart disease — but providing initial or increases to existing payments to the estimated 200,000 veterans who now qualify could take several months.

VA officials encourage all Vietnam veterans who were exposed to Agent Orange and suffer from one of the three diseases to make sure their applications have been submitted by calling 1-800-827-1000 or going online to <a href="https://www.fasttrack.va.gov">www.fasttrack.va.gov</a>.

Annual members are reminded that their membership in the Veterans of Foreign Wars of the United States expires December 31, 2010, unless their 2011 dues are paid and reported to Department and National Headquarters. Every effort should be made to renew the membership of continuous members and also sign up new and reinstated members prior to January 1, 2011.
